



METHODOLOGICAL NOTE

This is the methodological note for the figure on the fundings allocated in the period September 2021 to September 2022 by selected EU countries, Norway and the United Kingdom to shield households and firms from the rising energy prices and their consequences on the cost of living. Some of the announced measures will be rolled out in the upcoming months and years (please refer to the “Dates” column of the country tables). Figures to support utilities in meeting their liquidity needs - through loans, bailouts and fully fledged nationalisations – are also provided in gold. Everything in grey is related to the higher cost of living - mainly due to the undergoing energy crisis - but it is not included in our totals.
