



## Dataset updates

### European Union countries' recovery and resilience plans

#### 13 December 2022

- The Netherlands is added to 'Table 1: Available and requested grants and loans from the RRF'.
- Hungary and the Netherlands are added to 'Table 6: The Commission's assessment of the recovery plans'.

#### 9 June 2022

- Poland is added to 'Table 6: The Commission's assessment of the recovery plans'.

#### 27 April 2022

- Tables 2, 3, and 4 and Figures 3, 4, and 5 on the dataset webpage were updated to include all the 26 countries that have submitted their plan.
- Bulgaria and Sweden are added to 'Table 6: The Commission's assessment of the recovery plans'.

#### 25 March 2022

- Added data for Bulgaria, Malta, Ireland, and Denmark to the main dataset file.
- Removed the local currency columns from the source data, which was provided only for a few countries before.

- A new classification recommended by the authors of the dataset was added. This classification includes two levels: three main headline categories that we call 'Level 1': 1) Green transition, 2) Digital transformation, and 3) Social, economic, and institutional development), and within these three main headlines, altogether 35 sub-categories that we call 'Level 2'.

- Slovenian data in Figure 1 has been corrected. In the previous version, the entire amount of the RRF loans requested by Slovenia was erroneously assigned to the category "Other" (instead of recognising its green and digital components), and that led to some miscalculations.
